I am writing further to your request received by the Ministry of Health. Your request is for:

- **Correspondence, policies, briefing notes, meeting minutes, reports, and general records related to the development and implementation of the Health Hazard Regulation, passed in 1988 pursuant to the *Health Act*, via BC Regulation 181/88, deposited May 10, 1988. (See the BC Gazette, Part II, May 17, 1988, page 228). Date range is January 1, 1985 to December 31, 1990.**

The ministry conducted a thorough search, including archived offsite records and files transferred to the BC Centre for Disease Control in 1995, no records were located about the Health Hazard Regulation/*Health Act* for the time period requested. As no responsive records exist, your file with the ministry has been closed.
